 This warranty is not transferable. It extends to the original and first end-customer.

• 10 YEARS TERMITE DAMAGED SERVICE WARRANTY

In the event of FLOOR DEPOT floorboard is infested or affected by termite within the service warranty period, FLOOR DEPOT will provide SPOT repairing service and replacement of affected area floorboard or material at NO COST to the FIRST owner and ONCE only on the condition that the Fixing work must be executed by our authorized and recognized installation team. Upon notification of a claim being given, the FIRST PURCHASER/OWNER is subject to take all reasonable steps to minimize the extent of the termite damages, immediately engage Pest Control agent to provide termite control service prior to FLOOR DEPOT spot repairing and replacement service job.
